The sickest children, living the furthest from Vancouver and requiring the longest hospital stays: these are the children and families we care for every day at Ronald McDonald House BC.

Of the more than 80,000 patients who visit BC Children's Hospital every year, 68% of them live outside of Vancouver and most have no place to stay while receiving the life-saving medical care these young patients require. That's where Ronald McDonald House BC and Yukon comes in.

When a child is seriously ill or injured, the entire family is in crisis and suffers. Parents feel emotional and financial strains, being away from home and the need to juggle work-related responsibilities and family needs. Siblings are also thrust into the upheaval. Ronald McDonald House British Columbia is a nurturing and magical home-away-from-home for sick children and their families where, together, their lives are enhanced through unconditional support, encouragement, friendship and love.

Meet Emma

Needing specialist care even before her birth, baby Emma was born at BC Children's and Women's Hospital in Vancouver July 2014 and was the first baby born to a family staying at the new Ronald McDonald House.

Throughout the first year and a half of her life, this happy little girl has needed monthly and sometimes bi-weekly trips to specialist clinics in Vancouver, including neurology, gastroenterology, ophthalmology, and endocrinology. Thanks to RMH BC, her family has been able to stay by her side, helping her grow and reach important milestones.

For Emma's mom Jessie, RMH BC provides the caring support of a community when she is away from home. "I've made some lifelong friends here at the House," says Jessie. "You always have somebody to cry with, somebody to celebrate with, and a roof over your head." Emma's big sister Rhiannon can also come to stay, keeping the family together when they need each other the most.
