

Donating Securities as a Charitable Gift

By donating shares directly to Ronald McDonald House BC and Yukon, you get a larger tax credit and give more to families, as CRA does not apply capital gains tax on donations of appreciated publicly traded securities.

The donation is transacted by a simple electronic transfer of shares to Ronald McDonald House BC and Yukon through your professional advisor and our broker.

It's an easy and quick process and here's how it works:

- Please fill out the Transfer of Securities Form (required) on the next page, sign as the owner(s) of the shares, and include your professional advisor information.
- Please note our legal name: The Children's Family House Society of B.C. (Charitable Registration #: 119222404RR0001)
- You as the Owner (or your broker) then emails (or faxes) **both** RMH BC and our broker, RBC Dominion Securities, notifying us of your intention and donation.
- Based on RMH BC policy, all shares are immediately sold by our broker on our behalf.
- RMH BC is notified of the completed transaction and the funds are automatically transferred to our bank account.
- RMH BC generates a tax receipt mailed to the donor, based on the full transaction value (and
 potentially the currency rate for non-Canadian shares).
